- Dessert, snack or drink vendor (one type of product per vendor, e.g. lemonade, popcorn, etc.). Vendors may sell soda or water. NO wine, beer, or other alcoholic beverages may be sold.  
**Vendor fee: \$100**
- Food vendor whose business is located on Main Street, setting up in front of own restaurant. No cooking allowed outside; only sterno permitted. Vendor provides own tables, etc. Fee includes 10' x 10' space.  
**Vendor fee: \$50**
- Food vendor whose business is **not** located on Main Street. Not cooking with gas grill or sterno. Fee includes 10' x 10' space.  
**Vendor fee: \$200**
- Food vendor whose business is **not** located on Main Street. Cooking with gas grill or sterno. Fee includes 10' x 10' space, 10' x 10' tent, and 2 tables.  
**Vendor fee: \$300**

**Tents:** If you use an E-Z Up tent, you must use portable lighting. If you rent a fire-proof tent, then you may plug lighting into a lamp post for a \$25.00 additional fee. Portable gas generators may be used. If you use a tent larger than 10' x 10', then you must apply for a tent permit from the City of Dunedin.

- \$25.00 Electricity Fee** (not available for Drink/Dessert Vendors)

**Photocopies of proof of insurance and pertinent licensing must be included with application.**

Vendors must follow all Health Dept. and Fire Marshall requirements.

Set-up is between 1:00pm and 4:00pm on the day of the event. Breakdown is at 11:00pm.

Check in at the volunteer/vendor check-in area upon arrival. You will be assigned a location upon check-in.

City of Dunedin picnic tables will be spread along Main Street between Broadway and Highland Ave. for your convenience. The Fire Marshall requires that no loose tables and chairs be placed in the street.

**All fees due no later than January 5, 2008.** Applications received after January 5 will not be honored.
